The degrees for a dual degree are awarded upon successful completion of each degree, which most typically is sequential.	Degree will be awarded simultaneously	It is our understanding that students are supposed to graduate at the same time with both degrees. If students are using a thesis or dissertation to meet one of the College's requirements, then satisfactory completion of the thesis or dissertation is required in order for the College of Public Health degree to be awarded. Students who want to graduate with their MPH degree first must meet all the requirements of their COPH degree. This is an area that causes problems at time of certification (including problems with incomplete grades in the unfinished degree), so we are happy that the Graduate Council is looking at these requirements and look forward to clarification of some of the rules surrounding dual degrees.
Do you have any other observations for Council to consider?				It would seem that a dual degree is really an individual student decision. If some sort of dual knowledge bases, skills, etc are desired by a student, a possibly more realistic approach might be a strong cognate outside the program area would suffice. Alternatively, an individualized interdisciplinary degree (which we have in the College of Education) might be desirable. In our case, such a degree must include three distinct disciplines which may be totally within the college or may include one or two programs		 The dual degree application could be revised to include a place for students to list what courses are shared between the two programs. Clarification of rules regarding how many courses can be shared. If 9 credits of course work can be shared, for example, does this include courses that are "waived" (such as field experience and special project) because they are being covered by courses taken in their other program? Are changes/course substitutions allowed to the plan of study? When does a new plan of study need to be submitted? How to enforce this? Clarify communication process between the two colleges, especially at time of graduation. Clarification of the graduation requirements – whether it needs to be simultaneous, and if the plan was for a simultaneous graduation,
